

#### **Overview**

Relicia, abbreviated as REL, is a standard dangerous Seventh Density concept and the only one of her kind. There is no specific classification for her. The total conceptual mass of this entity has not been measured but is assumed to be around average size for incident-causing entities. Despite this small size, extreme measures were used in neutralization.

Relicia is confirmed to be neutralized, as the entirety of her conceptual mass was destroyed between a star and beam created by MOC25-AUT before they were collected and hired by the MOC. She poses no threat to the MOC.

Before her death, Relicia assumed two separate forms: A small, roughly trapezoidal cube made of a nonexistent black material with gold lettering. Images of this text have yet to be retrieved from within the Universe, so translation is not yet possible. MOC25-AUT reports that she could not read it, so it is likely not in English. Her other form was a young, golden-blonde, girl with gold-gray heterochromia dressed in a black sundress with golden lettering similar to that of her first form. She also wore a small black hair ribbon. MOC25-AUT has called her manner of speech "outdated," as well as pointing out her outfit was "actually kind of cute, now that I think about it."

#### **Background**

Relicia was discovered after stability in U-B271836 dropped and an investigation began. The Incident Resolution Specialists identified that the entity was native to another Universe, assumed to be U-D4000777 as it was the nearest Universe and had already been destroyed. Relicia had been manipulating the minds of the various humans of the Universe. After the initial scouting period, MOC13-CAU requested to be assigned to the case to resolve it herself. At some point, MOC12-LAW began working alongside her and planted a Paulina Lotte Device at an unspecified location, where it was obtained and used by MOC25-AUT before they were hired by the MOC.

Despite an IR Specialist team and two council members working together to resolve the incident, MOC25-AUT (before hiring) was solely responsible for the elimination of Relicia and her two accomplices who were not identified before their destruction. Almost no data collection was possible due to the swiftness of the resolution.

#### **Containment**

As the Relicia has been neutralized, containing her is neither possible nor necessary. Were she to be captured before neutralization, she would likely be contained within a standard MOC prison unit (Despite not being easily contained), though this may not have been necessary to begin with. According to MOC25-AUT, Relicia seemed to be a fairly reasonable person, considering that she evacuated the population of that Earth's Greenland before destroying it. Additionally, the only people harmed during the incident were those directly involved in the incident as well as those who had to pay for any damages that were caused, though this was only financial pain.

Due to Relicia's unnatural ability to bypass Universal Membranes, containment may have been challenging. There is no data on this ability, so all information regarding this is merely speculation based on what had been recorded before.

#### **Threat**

Relicia had a number of fairly unusual abilities.

- Easily travel through Universal Membranes despite assumed conceptual mass
- Easily casting aside physical mass
- Control of several billion humans at any given time
- Unhindered telepathic communication with those it has contacted
- Use of a nonexistent type of matter

Relicia was responsible for one known incident, but IR Specialist teams are searching for evidence of previous incidents. So far, only the U-B271836 Incident was known to be caused by her. Despite the state of her assumed origin Universe, U-D400777, there is little evidence that she caused it to reach that state.

MOC25-AUT has compared the incident caused by her to a form of playing, common for younger concepts testing out their powers. Considering the scale of her incident was as small as it was, this may be the case.

In her human form, she carried around a large scythe made of the same material as her first form, which may be in reference to Death. What this implies about her is unknown.

### History

Relicia was assumed to have come from U-D400777. Though she may have been to any number of Universes before, there is no way to prove this as she has been neutralized and no other records of her existence have been found. In U-B271836, she tried many different ways of taking over the world by abusing the stable time loop already present. For unknown reasons, another time loop began, nested inside the first, the last iteration of which caused MOC25-AUT to appear and resolve the incident, breaking both loops.

Due to her outdated manner of speech, dated to a period roughly between 1950-1980, Relicia may actually be older than expected, but there is no evidence for this. If this is the case, she may have remained in her Universe for several billions of years before breaching their UM. Some theories have arisen that she waited for stability to drop before leaving, though this is unlikely given her aptitude for breaching them.
