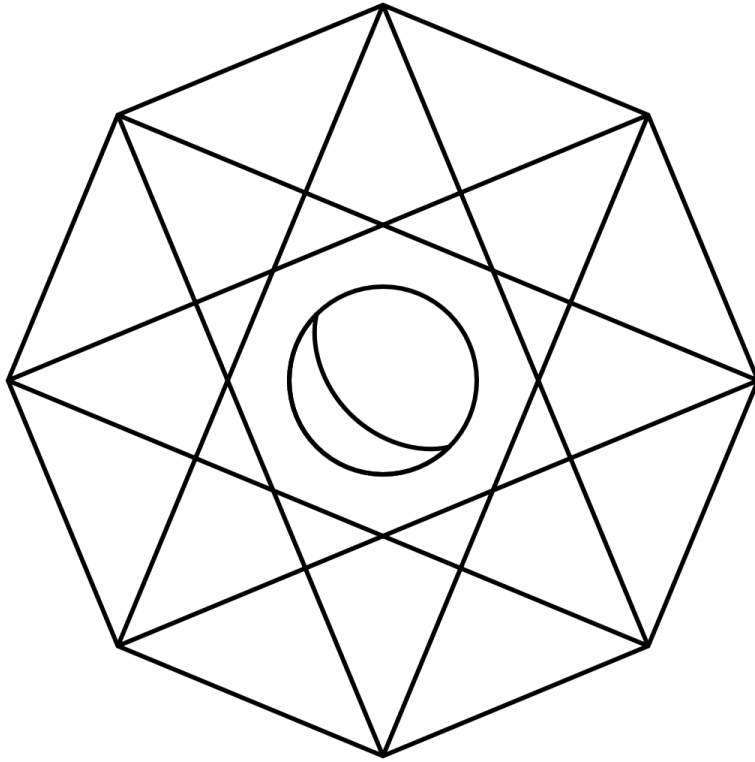

## Overview

Visnon-1, abbreviated as VN-1, is a VN-Class entity and the first of its kind. The classification is named after this one, resulting in others being referred to as a “Visnon” despite having different names. This is one of the largest VN-Class entities in existence, possibly the largest, as well as one of the largest concepts in general. Because of this large size and a both chaotic and psychotic nature, they also once posed an extreme threat to the MOC, though in the past this was not true.

VN-1 has effectively been neutralized, as a majority of its conceptual mass has been contained within The Sphere, a prison object constructed outside of Division Four.

VN-1 was confirmed to generate an offshoot concept at some point before becoming a threat, but outside sources confirm that this concept is deceased. Investigation of this claim has proven too expensive to pursue.

## Background

Though not often, VN-1 has come into contact with other VN-Class entities, in some cases before they were identified as such. It is not known what happened to them, but it is assumed they were killed and likely incorporated into VN-1's total mass. There is one confirmed entity that was not killed in such an interaction: [REDACTED]

VN-1 was the first one to be identified as a VN-Class entity, but not the first VN-Class entity encountered by the MOC. This one still remains the first on the ranking list, followed by VN-2 and VN-3. VN-Class entities are assigned a number based on the danger they may pose to the MOC and its mission. To avoid confusion, numbers are only put up for reassignment annually. Documents mentioning VN-Class entities are updated as soon as possible to reflect these changes.

Originally, VN-1 appeared to be a standard concept with abilities usual to most entities of this classification. At some point outside of MOC supervision this changed alongside their form and danger.

## Containment

VN-1 is currently contained in The Sphere, and will remain so indefinitely or until a method of “repairing” concepts is discovered. The Sphere is a large, spherical prison structure designed as a joint effort between the Paulina Lotte Company and MOC. It is designed using experimental fibers, U-Fibers, derived from a material similar to the Universal Membranes. These fibers cannot be recreated as the MOC was never informed of either the material cost or method of creation. Damage to The Sphere is considered permanent and to be avoided at all costs. The remainder of its structure is various other materials designed to keep the U-Fibers stable and contain the concept within. It is unknown whether or not the PLC made use of their Stabilifier technology to keep U-Fibers stable. There is no backup plan if The Sphere were to be destroyed, and the MOC’s first priority would be destruction of VN-1.

The Paulina Lotte Company was responsible for all of the theory behind The Sphere’s construction, as they made use of sciences not pursued by the MOC. They developed U-Fibers and blueprints before supplying them to the MOC for its employees to construct, as all PLC employees were human and bound by normal physical laws. Additionally, the MOC supplied all base resources required for the construction while the PLC created the parts in their laboratories to return to the site of The Sphere for final construction. The Sphere was designed with cameras inside the artificial UM, but at some point they were destroyed by VN-1 and further analysis is impossible without breaching the UM.

A portion of VN-1’s total conceptual mass is unaccounted for, and therefore not contained within The Sphere. It has been confirmed that this mass is somewhere in Reality, but its whereabouts are unknown. A majority of the conceptual mass, including the most active and intelligent portions, are contained and therefore reduce the threat of any remaining mass to nearly nothing. Search parties have been sent out to identify and retrieve this mass, but for several thousand years nothing has been found.

## Threat

Visnon-1 has been reported to have a number of dangerous and unusual abilities.

- Extreme regenerative capabilities
- Abnormally resilient conceptual mass
- Disintegrate & consume a worrying number of things
- Endless hunger
- Easily compressing matter to the point of creating black holes

The most major incident related to Visnon-1 occurred several thousand years ago, which resulted in the total destruction of U-763998 before the incident could be resolved. All life in said Universe was subsequently destroyed. VN-1 was then captured en route to the next nearest Universe and prepared for containment at The Sphere.

After being captured, an escape attempt was made, which almost resulted in heavy damage to MOCmHQ9 before it was expanded to accommodate the larger number of employees traveling to Division Four. The entity was then baited into The Sphere and contained.

## History

Several hundred years before the founding of the Paulina Lotte Company, [REDACTED] but they were turned down as their abilities were too much of a liability at the time. [REDACTED]

After being turned down by the MOC, VN-1 disappeared until the time period of the PLC, where it began an incident and was tracked down by the MOC and captured. The PLC offered to contribute to containment. The incident was too severe to be resolved, and resulted in the destruction of U-C763998 in Division Four before attempts to save anything could be made. No records of any activity from VN-1 exist between their introduction and first incident.

In early containment before the construction of The Sphere, severity of the entity gradually increased over time as more incidents occurred. It is assumed that a progressive conceptual disease was contracted and eventually took over VN-1's body and mind. Actual details on this theory are unknown. The disease may have worsened since containment, but this claim is unverifiable as the cameras installed within the U-Fibers have been destroyed and cannot be safely replaced.
